Teaching and scientific commitment	<p>Teaching and Scientific commitment will concern the academic discipline: MED/01 - MEDICAL STATISTICS</p> <p>The researcher will direct his or her research path mainly in the area of population studies conducted at the EPIMED Research Center. Methodologically, these studies are characterized by the availability of phenotypic data (psychological, socioeconomic, environmental, behavioral factors, biological and molecular markers), and a longitudinal design that includes both repeated measures and follow-up data on major diseases. In addition, participation in international consortia poses additional challenges, such as the need for meta-analytic approaches to account for heterogeneity across studies. The researcher will contribute to the development of new lines of research by planning and performing statistical analyses appropriate to</p>





	the design and complexity of the data; conducting validation studies of measurement tools (e.g., questionnaires); planning new studies and expanding existing ones.

Admission and Eligibility requirements	<p>Requirements for participation:</p> <ul style="list-style-type: none"><li>- PhD or equivalent qualification, obtained in Italy or abroad</li><li>- Medical Specialization Diploma (for medical area positions)</li></ul> <p>Candidates must possess the established requirement at the closing date of the applications' submission. PhD's awarded abroad need to be certified equivalent to the Italian degree, and the process needs to be initiated before the call deadline. Candidates need to apply for an "equivalence" certificate to the Ministry of Education and Research (MIUR), and attach the receipt of the equivalence request to the job application. Otherwise candidates can upload the equipollence decree of their PhD.</p> <p>Exclusion from the selection procedure will be provided via a reasoned measure from the Rector communicated to those concerned.</p> <p>Also, under no circumstances may those with family relationship up to the 4th degree with professors to the recruiting Department including the Rector, General Director, or any member of the Board of Governors of the University, participate in the procedure.</p> <p>The following applicants may not participate in the selection procedures:</p> <ol style="list-style-type: none"><li>1) Those who are not entitled to exercise civil and political rights;</li><li>2) Those who have been dismissed or relieved from office with a Public Administration for consistently poor performance;</li><li>3) Those who have been dismissed from a civil service job in accordance with art. 127, section (d) of Pres. Decree 3, 10.01.1957;</li><li>4) Those who have already been employed on permanent positions as full and associate professors or as researchers (even if no longer in service) or those who have already been employed as RTT Tenure track Researcher for at least three years.</li></ol> <p>This Administration guarantees fairness and equal opportunity to men and women in access to employment and employment conditions.</p>

<p>Application for the selection procedure</p>	<p>To participate in the selection, candidates must submit their application only using the procedure available on the web at: <a href="https://pica.cineca.it/uninsubria/">https://pica.cineca.it/uninsubria/</a> otherwise they will be excluded from the selection.</p> <p>The application may be filled via web using any computer with Internet connection within the deadline. Note: You need to complete the application by completing all required fields and attaching all required files.</p> <p>Candidates should submit:</p> <ol style="list-style-type: none"> <li>1. the application form, which has to be signed, under penalty of exclusion;</li> <li>2. a copy of a valid identity document (either Identity Card or Passport);</li> <li>3. a copy of fiscal ID;</li> <li>4. CV, duly dated and signed;</li> <li>5. pdf file of “dichiarazione sostitutiva di atto di notorietà” (attached outline “Allegato A”) duly dated and signed, which certifies that every information in the CV is true;</li> <li>6. That they are not related by blood or marriage up to the “fourth degree of kinship” (as understood in Italian, e.g. up to cousins and cousins of the candidate’s spouse) to the Rector, the university’s Managing Director, a member of the university’s Board of Governors or a Professor working at the Department involved are not permitted to apply for the post advertised here.</p> <p>8. That they are in possession of one of the requirements for admission indicated in art. 2 of this selection call;</p> <p>9. That they have possible preferential titles pursuant to art.5 c. 4 e 5 of D.P.R. n. 487 /1994.</p> <p>9. That they have adequate Italian language knowledge;</p> <p>10. Scientific Publications	<p>Candidates must upload their publications in .pdf of the capacity of 30 MB each one. If your publication exceeds 30 MB, you can split it following the number order in your publications list (attached B) e.g. publication n. 1 – title – part n. 1 etc.</p> <p>Published works not uploaded within the closing date shall not be taken into consideration by the Examining Board, even if they are mentioned in the publications list (attached B – publications list).</p> <p>If a candidate presents more publications than required, the Examining Board will evaluate the publications in the order specified in the list of publications produced by the candidate, up to the limit provided.</p> <p>For the purposes of this selection procedure only published works or texts accepted for publication as provided under current standards shall be accepted for evaluation, along with essays in anthologies and journal articles published in hard copy or digital format excluding internal notes or departmental reports. Publications have to take into account the current legislation regarding editorial activity and copyright.</p> <p>For joint-authored publications, the candidates may include a statement confirming their contribution. Otherwise, joint-authored publications may be evaluated provided it is possible to identify the individual contribution of the candidate on the basis of its coherence with their overall scientific activity.</p> <p>Publications have to be edited in Italian, French, English, German and Spanish. In case of procedures in linguistic subjects, it is also admitted the relative language mentioned in the announcement.</p>



	The University can carry out controls and ask for the original papers and publications.
Exclusion from the competition	Candidates are conditionally admitted to the selection procedure. The exclusion, due to lack of the requirements on the expiry date, can be ordered at any time. The exclusion is ordered by motivated Rector's decree and is notified to the person concerned.
Examining Commission	<p>The Commission is identified in accordance with the provisions of the University Regulation governing the public selection procedures for RTT tenure track researchers and is appointed by a Rector's Decree, published online on the University website.</p> <p>The Commission is composed of three members active in the research area which include the Academic Recruitment Field in this selection procedure.</p> <p>Gender representation should be normally guaranteed in the establishment of the commission, in accordance with the Recommendation of the Commission of the European Communities n. 251 of 11<sup>th</sup> March 2005 (on the European Charter for Researchers and on a Code of Conduct for the Recruitment of Researchers).</p> <p>For further details please see the original Italian version of the announcement.</p>
