This guide explains the fees you need to pay, how to submit your ISEE to apply for financial aid, how to request refunds, and how to make payments.

TUITION FEE FOR FOREIGN STUDENTS

The tuition fee consists of two parts:

- a Registration fee € 156,00 first instalment
- a Tuition fee second instalment

The tuition fee/contribution has to be paid in two steps:

- Deposit by December
- Balance by May.

Registration fee

It is the same amount for all students enrolled in Bachelor's, Master's and single-cycle Master's degree programmes

- regional tax of € 140,00
- stamp duty of € 16,00

Tuition fee

For all foreign students who have foreign citizenship and the household that produces income and property abroad, the amount of TUITION FEE is fixed, **FLAT RATE based on the country of origin and the area coefficient of the course of study** to which they will be enrolled or intend to enroll.

The flat rate is allocated at the time of enrolment and is maintained for the duration of the degree programme, if the student retains the condition of "Studente regolare".

If the student enrolls as off course, he becomes a "Studente non regolare", then the amount of the flat rate will increase.

For the purposes of determining the flat rate, foreign countries are grouped into three homogeneous groups, see Tables 1, 2 and 3 (at the end of the page). The particularly poor and developing countries indicated by DM of 12 February 2021 n. 156 are included in Table 1;

Each amount then counts the corrective coefficient K relative to the area of belonging to its degree program according to the scheme below:

DEADLINE FOR PAYMENT OF THE CONTRIBUTION AND LATE PAYMENT

If the tuition fee is less than or equal to € 400, the payment is made in a single solution with expiration on 19/12/2025. If the contribution exceeds € 400 the payment is divided into:

- a 30% deposit - deadline 19/12/2025;
- a 70% balance - deadline on 29/05/2026.

Attention: students who enrol in Master's degree courses with free access, after 19/12/2025 can pay the deposit of the tuition fee by 31/03/2026 and the balance by 29/05/2026.

Payments made after due dates generate **additional fee**:

- € 50,00 up to 30 days. from the respective deadline
- € 100.00 over 30 days. from the expected deadline.

ISEE PARIFICATO

All international students must apply for ISEE PARIFICATO to participate in the calls issued by the right to study, scholarship, accommodation. (BANDO BENIFICI ECONOMICI BORSA REGIONALE, ALLOGGI A TARIFFA PIENA, COLLEGIO DI MERITO)

They must contact the CAF office indicate on the website.

Foreign students must deliver to the CAF the following original documents:

- document certifying the composition of the foreign household;
- 2023 calendar year income of each member of the household (the document must clearly state that the income refers to the year 2023)
- the balance sheet relating to buildings owned on 31 December 2023 with an indication of square metres;
- attestation of transferable assets held on 31 December 2023 by each household member (current accounts, securities, equity, dividends, equity, etc.)

This documentation must be:

- issued by the competent authorities of the State in which the income was produced;
- translated and legalized by Italian diplomatic missions or consular posts abroad.





The documentation can also be issued by foreign diplomatic/consular representations in Italy for those countries where there are difficulties in issuing the certification certified by the local Italian embassy and legalized by the prefectures pursuant to art. 33 of DPR 445/2000.

REFUNDS

You can ask for a refund of the **regional tax (140,00 €)** only in the following cases:

- Students who renew their enrolment at a.y. 2025/2026 and who graduate within the extraordinary session of a.y. 2024/2025, provided the request for reimbursement is submitted within 30 days from the final degree.
- Students who have not been able to complete the registration and its subsequent cancellation.
- Students who have made a double registration: according to the provisions issued by the Lombardy Region, the reimbursement of the regional tax must be asked directly to the University of second registration.
- The stamp duty cannot be refunded.

It is also possible to proceed to reimbursement in the cases of:

- Students who pay more than they should due to double payments, material errors or recalculation of fees: the difference will be refunded upon request.
- Students enrolled, in possession of a diploma for the access to university courses obtained abroad: a reduction of the single contribution equal to the cost for the issuance of the certificate of comparability € 150.00 and the certificate of verification CIMEA 65.00 €. The reduction will apply only to certificates deemed necessary for the purposes of enrolment and within the limits of the university contribution due. There is no reduction if the student does not have to pay a university contribution.

In order to obtain the required refunds, the student must complete the form together with a copy of the identity document, attaching the certificates and/or receipts of payment of the amounts for which reimbursement is requested: without the receipts it is in no way possible to proceed to the refund.

The student, before requesting a refund, if he has not already done so, must apply for the admission to the banking services of his Carta Ateneo, which becomes the only way of managing financial relations between the University. In addition, the same will have to check the correctness of personal data in their personal web area.





HOW TO MAKE A PAYMENT

The Pago PA system is the only means of payment for the payment of tuition fees. PAGO PA is an electronic payment system designed to make any payment to the Public Administration easier, safer and more transparent.

You can make payments directly on the Institution's website or mobile application or through the physical and online channels of banks and other Payment Service Providers, such as:

- At the agencies of the bank
- Use of PSP home banking (recognizable by CBILL or pagoPA logos)
- At authorised bank ATMs
- In the shops of Mooney, Lottomatica and Banca 5
- At the city post office.

The Pago PA payment notice will be made available and printable by linking to the Segreterie Studenti Servizi Web accessible from the homepage of the Uninsubria portal.

The printing of the payment notices and the respect of the deadlines for the payment of the tuition fee themselves are the responsibility of the students.

The registration of the payment is immediate and therefore it will not be necessary to present any receipt at the counters.

Receipts from payments shall be retained for the duration of studies.

Please note that for some banks you will need to use the following code BE: AW2GY

The payment transactions made through the CARTA ATENEO do not involve any bank charge.





HOW TO RECEIVE A PAYMENT (scholarships, refunds)

CARTA ATENEO

To receive a payment **you must activate the CARTA ATENEO** by enabling it to the banking services at the Banca Popolare di Sondrio.

The activation of the Card can be made, **going to any branch of the Banca Popolare di Sondrio (no online activation).**

Once it has been approved, you must enter the IBAN code directly in the Segreterie Studenti Servizi Web, you can follow the guide instructions that you find of the web site.
